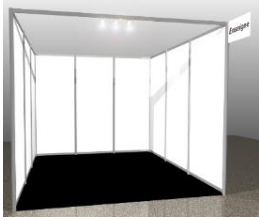

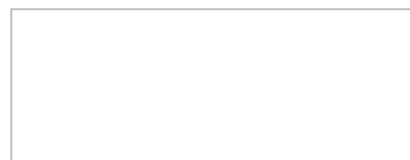

**Event name:** APS MEETINGS 2025 (referred to as the "Event");

**Dates:** 26 & 27 March 2025 (referred to as the "Event date")

**Location:** Double Mixte (referred to as the "Place");

**City, Country:** Lyon, France

**1/ ORGANIZATION** The Event is organized by abe - advanced business events, a limited company with a stated capital of 50000 Euros, whose registered head office is located at 10, rue de la Rochefoucauld SC 50300 - 92513 Boulogne-Billancourt – France, hereafter referred to as the Organizer.

## 2/ PURPOSE

This agreement stipulates the terms and conditions, under which the Organizer sets up and runs the Event.
